1. Motion Title: Reimbursing the Morning After Pill to all JCR members

Proposed by: Raksha Raghuraman

Seconded by: Ashi Banerjee

Motion passed (no opposition)

Questions raised:

CN - Is there a limit to how many pills a student can be reimbursed for? No.

The meeting noted that:

For clarity, the private message regarding the Morning After Pill would be to the Welfare Officers.

2. Motion Title: Purchase of 50 assault alarms

Proposed by: Ashi Banerjee

Seconded by: Raksha Raghuraman

Motion passed with amendment

Amendments:

- (JG) The JCR resolves to set aside £499 in the budget for the purchase of an unspecified quantity of assault alarms. (passed)

Questions raised:

- (JG) How many people have requested alarms? 8.
- (ES) What is the practical difference between alarms of different values? Unsure.

The meeting noted that:

- (RR) The 8 requests made were in a single day thus it is assumed demand will increase.
- (TL) The proposer could research into a discount from the Rape Crisis Centre/find local alternatives.
- (TL) The requests for alarms are a matter of urgency.
- (MA) To make requesting personal safety equipment clearer it could be separated from the form about sexual health.
- (AB) The current welfare budget could accommodate this, but it would take money away from elsewhere.
- (JB) Last year's welfare team had a much bigger budget.

3. Motion Title: Lacrosse sticks for the St Hilda's Lacrosse Club

Proposed by: Cristina Marson

Seconded by: Max Harper

Motion passed with amendment

Amendments:

- (MH) The JCR resolves to provide £100 to the St Hilda's Lacrosse Club for the purchase of 10 lacrosse sticks. (passed, no opposition)

Questions raise:

- (BP) How many sticks does the club currently have? 8. (amended 11, see below)
- (AB) What is the range of value of lacrosse sticks? 20-100s. Requesting for £20 sticks.
- (ES) How many members in the club? Approx. 12.
- (ES) Do any members have their own sticks? No.

The meeting noted that:

- (WF) there are 3 lacrosse sticks in Fulford that will be returned.
